In addition to report 2020-CO-40 re. consideration of adding stop signs on Rynard Street, on behalf of many neighbours in the Sunderland Meadows Subdivision, I would like to add the following:

- Request for additional stop signs on Rynard Street was first requested on March 6, 2018, see attached. The reasons for this request are still very much still valid.
- The speeding of cars and motorcycles going north and south is still a problem

Subject: Requested change of stop sign in Sunderland

Dear staff and members of Council,

Already after a short while living in the Sunderland Meadows sub-division, it's obvious that we are facing a challenge with speed of the cars on Rynard Street and the subsequent safety hazard for children and other pedestrians.

My proposal is to change the stop signage of Rynard Street northbound and southbound to a mandatory stops making the intersection a three-way stop.

The arguments can be summarized as follows:

- 1) Rynard Street is a straight road and thus inviting drivers to accelerate and thus easily exceeding the posted speed limit, currently 20 km/hr. A stop sign will certainly reduce the speed.
- 2) The north/south sidewalk is located on the west side of Rynard St. and since most pedestrians are walking to/from River Street means they need to cross Rynard street to the east side.
- 3) The location of super-mailbox is located on the east side of Rynard Street while the sidewalks is located on the west side. This means a number of pedestrians will cross the road to visit the mailbox. See sketch over.

This proposal has the support of many of the affected neighbors even though no formal petition has been arranged at this point in time.



It is my hope that council and staff can support this proposal to make it happen before any accident will happen.
