1. Call to Order

Chair Munro called the meeting to order at 9:22 a.m.

2. Confirmation of Minutes

Moved by Lynn Campbell that the minutes of the January 21, 2020 meeting be approved.

3. Hearing of Deputations

4. General Items

- 1) Durham Region Accessibility Awards 2020 Nomination
- 2) Township of Brock Accessibility Award 2020 Nomination

The Clerk's Assistant (Ms. Donnelly) advised that nominations for the Township of Brock Accessibility Award 2020 were put on hold due to the pandemic. The Clerk's Assistant (Ms. Donnelly) queried B.A.A.C. members to see if they were interested in putting forth a nomination and presenting the award virtually or if they would prefer to cancel the Township of Brock Accessibility Award 2020 (due to the pandemic) and proceed with nominations in 2021.

Ms. Foreman indicated that she would like to proceed with nominations, stating the importance of accessibility especially during the pandemic. Ms. Foreman credited the businesses that implemented

changes during the pandemic and didn't lose sight of accessibility (i.e. stores opening early). Ms. Schirle stated that her preference would be to defer nominations since there hasn't been an opportunity to investigate / look at worthy businesses due to the pandemic. After further discussion, members agreed to proceed with nominations. Ms. Foreman recognized that Fisher's Your Independent Grocer opened early for seniors and individuals with compromised immune systems.

A brief discussion ensued with respect to whether nominations would be open to the public to which it was decided they would not.

Councillor Campbell noted that the front entrance doors at Foodland, Cannington are accessible and stated that they removed one aisle making the store more accessible and easier to move around in. Chair Munro also agreed that Foodland has been improved.

Councillor Campbell recognized the efforts of Home Hardware, Cannington during the pandemic advising that staff members would greet the public outside of the store and go inside to get the requested items.

Ms. Foremen advised that Fisher's Your Independent Grocer offered online shopping and that she used this service herself.

Chair Munro stated that Foodland really elevated their service delivery. Councillor Campbell advised that Foodland is now more spacious.

Ms. Foreman recommended that B.A.A.C. decide which grocery store had more of a Regional vs. Township impact. It was agreed that Fisher's reaches more customers in the Region due to location.

The Clerk's Assistant (Ms. Donnelly) advised that the nomination deadline for the Durham Region Accessibility Award 2020 is October 16, 2020.

Members continued discussions and agreed to nominate Foodland, Cannington for the Township of Brock Accessibility Award 2020 and to nominate Fisher's Your Independent Grocer for the Durham Region Accessibility Award 2020.

Moved by <u>Chair Munro</u> that B.A.A.C. recommend that Foodland, Cannington be nominated for the Township of Brock Accessibility Award 2020 for the installation of new automatic doors (at the front entrance) and brighter lighting; wider aisles and redesigned checkout counters allow more room for customers and shopping carts; continuing to offer phone in / delivery services during the pandemic. Further, that a virtual presentation be arranged to present this award.

MOTION CARRIED

Moved by <u>Chair Munro</u> that B.A.A.C recommend that Fisher's Your Independent Grocer be nominated for the Durham Region Accessibility Award 2020 for quickly adopting and responding to the needs of their customers during the pandemic. Fisher's opened early to accommodate seniors and individuals with compromised immune systems, provided an option to shop online with groceries delivered to vehicles, and improved the flow of aisles making it easier and safer to move around the store.

As a reminder, Chair Munro provided an overview of the criteria for the Township of Brock Accessibility Award.

5. Other Items & Inquiries

- 1) Chair Munro opened the floor to roundtable discussions. Chair Munro inquired as to whether any members had any accessibility concerns as a result of the COVID-19 pandemic. Chair Munro asked if services were still being provided at the Township of Brock administration building to which the Clerk's Assistant (Ms. Donnelly) advised that services are being provided by appointment only.
- Discussions ensued with respect to future meetings. The Clerk's Assistant (Ms. Donnelly) advised that future meetings will continue per the approved 2020 schedule and that meetings will be held electronically until further notice. Further discussions ensued regarding the time of the meetings to which The Clerk's Assistant (Ms. Donnelly) advised that a motion is required to change the time of meetings. B.A.A.C. members agreed to continue with meetings at 7:00 p.m. (per the schedule).

For information purposes, Councillor Campbell informed B.A.A.C. members that Council adopted a resolution wherein Council members are permitted to participate at meetings via electronic means. Councillor Campbell provided positive feedback with respect to electronic meetings stating that it is convenient and ensures everyone's safety.


